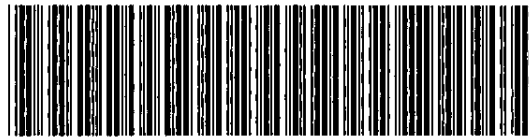



M.D.


ARTICLE VII
