**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
TSARS PROPERTIES, LLC**

Pursuant to Section 608.411 of the Florida Limited Liability Act, the undersigned, on behalf and in the name of TSARS PROPERTIES, LLC, a Florida limited liability company (the "Company"), adopts these Articles of Amendment.

1. The name of the Company is Tsars Properties, LLC.
2. The Articles of Organization were filed on November 2, 2012, and assigned document number L12000139930.
3. The Articles of Organization of this Company are amended by modifying and amending Article I in its entirety and replacing it with the following:
