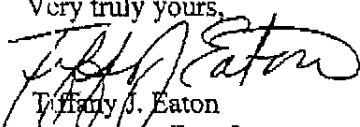

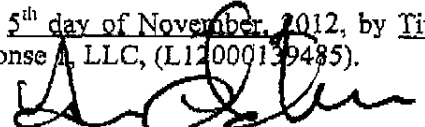
As such we, we have no intention to revoke the dissolution of L12000139485, and therefore release the name to Live Agent Response 1, LLC, W12000056072 for immediate use.
