ARTICLES OF ORGANIZATION

OF

MARCEL CAPITAL, LLC

of forming a limited liability

The undersigned, Marcel M. Mohseni, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability Company shall be MARCEL CAPITAL, LLC ("Company").

ARTICLE IV - PURPOSE AND POWERS



Any Company action shall be authorized and taken by no less than a majority in interest of the votes cast by the Members entitled to vote thereon

ARTICLE VII - ADMISSION OF NEW MEMBERS
