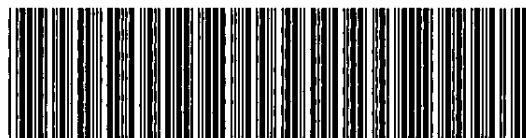



ARTICLES OF ORGANIZATION OF

WE BUILT THIS, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be WE BUILT THIS, LLC.

ARTICLE II - ADDRESS

ARTICLE V - MEMBERSHIP RESTRICTIONS

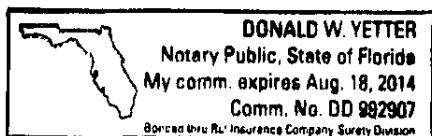


