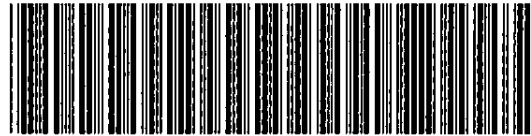

Name**

Continuation of Business

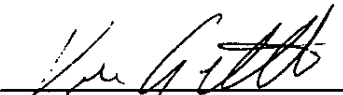
