The name of the Limited Liability Company is "**Warehouse 101, LLC**" (the "**Company**").

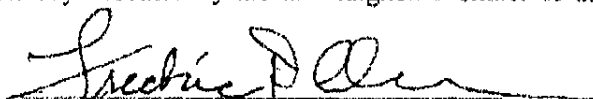

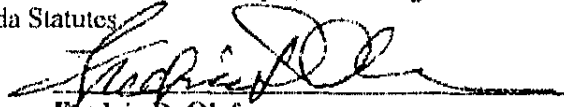
