The name of the limited liability company shall be C&M RE, LLC (the "Company").

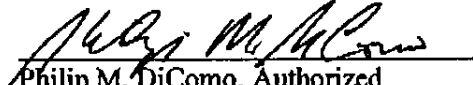
**ARTICLE II - ADDRESS**
