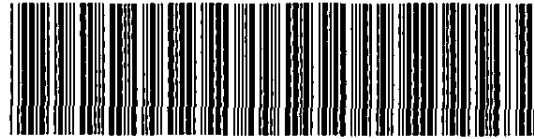

Principal Office


