**ARTICLES OF ORGANIZATION
OF

The undersigned hereby forms a limited liability company with the meaning of the applicable provision of Chapter 608, Florida Statutes.

**ARTICLE I
NAME**

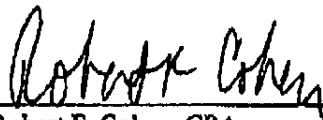
