ARTICLE I -- NAME

The mailing address and street address of the principal office of the Company shall be 3063 N. W. 23rd Terrace, Fort Lauderdale, FL 33311.


ARTICLE III-- DURATION

#### ARTICLE V -- ADMISSION OF NEW MEMBERS
