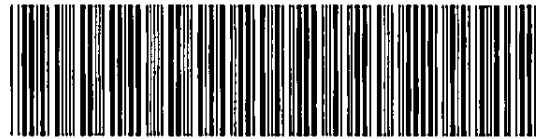

**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
FOR  
PUSILLO PAINTING, LLC  
A Florida Limited Liability Company**

This Limited Liability Company was formed, upon the filing of the original Articles of Organization with the Florida Secretary of State (Florida document number L12000145396). These Amended and Restated Articles of Organization shall supersede the original Articles of Organization, which have not been previously amended. The Articles of Organization are hereby amended and restated in full as herein set forth:

**ARTICLE I  
NAME**

The name of the Limited Liability Company is amended and shall be hereafter known as ***PUSILLO WINDOWS & DOORS, LLC*** (the "Limited Liability Company").
