ARTICLES OF ORGANIZATION

of

REVOLUTION GIRL, LLC (A Florida Limited Liability Company)

The undersigned, desiring to form a Limited Liability Company in the State of Florida pursuant to Chapter 608, F.S., hereby certifies:

ARTICLE I - NAME

The name of the limited liability company shall be Revolution Girl, LLC, hereinafter referred to as the "Company."

ARTICLE II - ADDRESS

The principal street address and mailing address of the Company is 2611 W. Thornton Avenue, Tampa, FL 33611.

ARTICLE III - PURPOSE

The Company is organized to conduct business for any and all lawful purposes under the laws of the State of Florida.

ARTICLE IV - MANAGEMENT

The Company shall be managed by one or more members, and therefore will be a member-managed company. The initial managers of the Company shall be Sandy Jordan and Heath McKenzie. The Operating Agreement may contain additional information or provisions concerning the management and regulation of the Company and its affairs, but shall not be inconsistent with the laws of the State of Florida or these Articles.

ARTICLE V - REGISTERED AGENT

The Registered Agent of the Company shall be Heath McKenzie. The address of the Registered Office is 2611 W. Thornton Avenue, Tampa, FL 33611. The Registered Agent accepts this designation and agrees to comply with the provisions of Chapter 608 F.S. regarding the same.

ARTICLE VI - DURATION

The Company's duration shall commence upon the filing of these Articles with the Florida Department of State and shall continue in perpetual existence, unless earlier dissolved: (i) in accordance with the Company's Operating Agreement, or (ii) upon unanimous written consent of all the members' interests.

ARTICLE VII - AMENDMENT

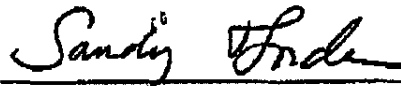
These Articles may be amended only as provided by law or in accordance with the Company's Operating Agreement.
