ARTICLES OF ORGANIZATION OF QUEO CONSULTING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

Article 1 - Name

The name of the limited liability company shall be QUEO CONSULTING, LLC.

Article 6 - Registered Office and Registered Agent


