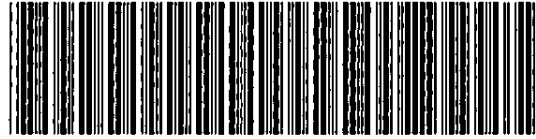

The name of the Limited Liability Company is "**JCR Family Management, LLC**" (the "**Company**").




