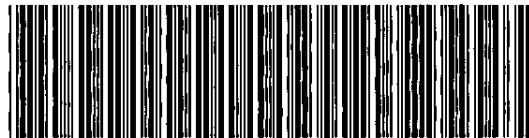

The principal place of business and mailing address of the Company is 7121 Fairway Drive, Suite 301, Palm Beach Gardens, Florida 33418.




