ARTICLES OF ORGANIZATION

OF

ESTHETIC DENTISTRY SEMINARS, LLC

The undersigned initial member(s) of ESTHETIC DENTISTRY SEMINARS, LLC, a Florida limited liability company formed hereunder (the "Company"), hereby form a limited liability company under the laws of the State of Florida.

ARTICLE I. COMPANY NAME

ARTICLE II. COMMENCEMENT AND TERM OF EXISTENCE

In accordance with Section 608.409(1) of the Florida Limited Liability Company Act (the "Act"), the term of existence of the Company shall commence on Dec 5, 2012, and shall continue until December 31, 2056, unless otherwise dissolved pursuant to Article VIII of these Articles of Organization.

ARTICLE VII. RIGHT OF ASSIGNEE TO BECOME A MEMBER

ARTICLE VIII. DISSOLUTION OF COMPANY

Upon the death, bankruptcy or dissolution of a member or upon the occurrence of any other event provided in the Regulations of the Company, the Company shall be dissolved unless the surviving members elect to continue the Company upon the unanimous vote of all the members of Company which vote is taken at a duly called meeting of the members or by written consent of all members of the Company.

ARTICLE IX. MANAGEMENT OF THE COMPANY

The Company shall be managed by the member(s) of the Company whose name(s) is/are set forth below:

ARTICLE X. RETURN OF CAPITAL
