WHEREAS, all of the Members of the Company desire for the Company to be dissolved.

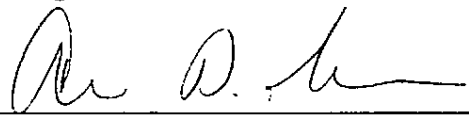
