Principal Office

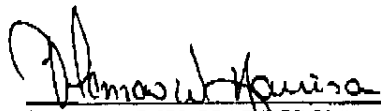

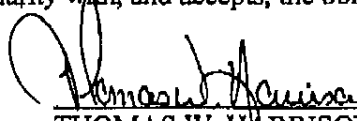
