The name of the Limited Liability Company is "EG Advisors, LLC" (the "Company").

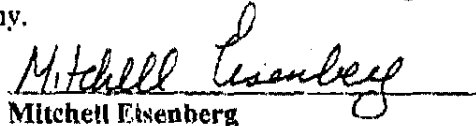
**Article II.
