Name

the majority of the organizers should dissolve the Limited Liability Company.

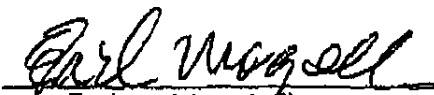
ARTICLE IV
