
ARTICLES OF ORGANIZATION FOR

The remaining members of the limited liability company may continue the business of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company
