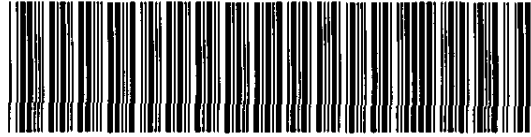

FIRST: The name of the Limited Liability Company is PRG TRADEPORT LLC.


