

ARTICLES OF ORGANIZATION OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is SMART HOME RENTALS, LLC.

ARTICLE II - MAILING ADDRESS

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in SMART HOME RENTALS, LLC, the remaining Members may, by unanimous agreement, continue the business of SMART HOME RENTALS, LLC.

ARTICLE VII - MANAGEMENT
