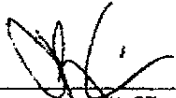

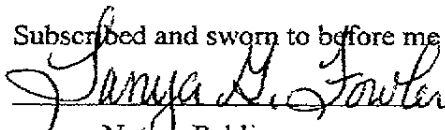
Before me, the undersigned notary public, this day, personally appeared Oscar R. Cisneros personally known to me, who being duly sworn according to law, deposes the following:
