Pursuant to Section 605.0202, Florida Statutes (2014), the undersigned, as the sole Member of MH Sarasota Management, LLC (the "Company"), hereby certifies to the following for the purpose of amending the Articles of Organization for the Company:

1. The name of the Company is MH Sarasota Management, LLC, a Florida limited liability company.
