**ARTICLES OF ORGANIZATION
OF
TIDEWATER CAPITAL INVESTMENT, LLC**

Pursuant to the provisions of Chapter 608, Florida Statutes, the undersigned being authorized to execute and file these Articles, adopts the following Limited Liability Company Articles of Organization:

ARTICLE I - NAME

The name of this Limited Liability Company is Tidewater Capital Investment.

ARTICLE II - MAILING ADDRESS AND STREET ADDRESS

ARTICLE VIII - CONTINUATION OF BUSINESS

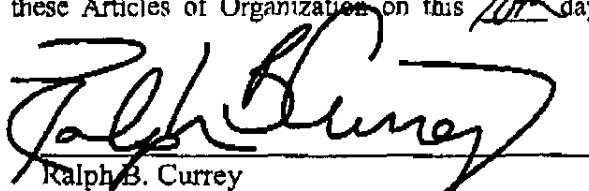

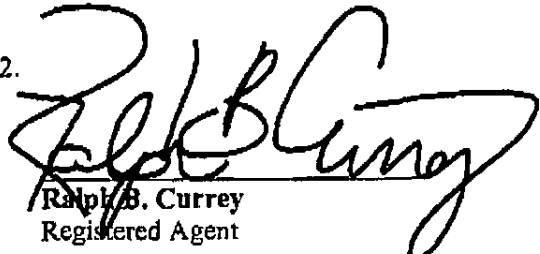
