ARTICLES OF ORGANIZATION
OF
THE PAPES FAMILY FLORIDA LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be THE PAPES FAMILY FLORIDA LLC (the "Company").

ARTICLE II -- ADDRESS

The street address and mailing address of the Company shall be 8205 Woburn Drive, Raleigh, NC 27615.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. ARTICLE IV -- REGISTERED OFFICE AND AGENT




