**SECOND:** The Articles of Organization were filed by the Company on December 12, 2012 and assigned document number L12000155390.

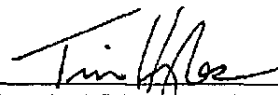
**THIRD:** The following amendment to the Articles of Organization has been adopted by the Company:
