# ARTICLES OF ORGANIZATION OF PICCOLO ARTIST, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

#### ARTICLE I NAME

The name of the limited liability company is Piccolo Artist, LLC (the "Company").

## ARTICLE II MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 888 Brickell Key Drive, Suite 211, Miami, Florida 33131.

#### ARTICLE III REGISTERED AGENT AND OFFICE

#### ARTICLE IV DURATION

The Company shall commence its existence on the date that the Articles are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in the Operating Agreement.

#### ARTICLE VII MANAGEMENT; INITIAL MANAGER

The Company shall be a manager-managed limited liability company and shall be managed in accordance with the Operating Agreement adopted by the company for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the business and operations of the Company, not inconsistent with Florida law or the Articles. The initial Manager of the Company shall be Rebecca Drucker, 888 Brickell Key Drive, Suite 211, Miami, Florida 33131.

#### ARTICLE VIII AMENDMENT

The Articles may be amended only in accordance with the Operating Agreement.
