
**ARTICLES OF ORGANIZATION

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, the following are the Articles of Organization for CLU HEARING AIDS, LLC (the "Company"):

1. Name. The name of the Company is CLU HEARING AIDS, LLC.
