HATSFELT and MICHAEL ROBERT JOHNSON, natural persons competent to contract and the members of SEI-GROUP HOLDINGS, LLC, hereby present these Articles of Organization as the Articles of Organization of SEI-GROUP HOLDINGS, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is SEI-GROUP HOLDINGS, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
