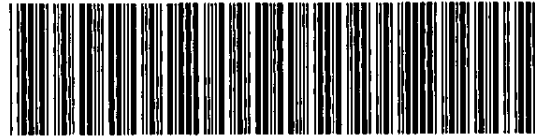

SECOND: The Company's Articles of Organization are hereby amended as follows:


ARTICLE III - Management
