These Articles of Correction correct the Articles of Organization of 3D Exploration, LLC, as filed with the Department of State on December 14, 2012.

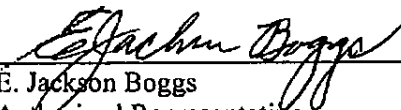
Article I of the Articles of Organization is hereby corrected by deleting it in its entirety and replacing it with the following:
