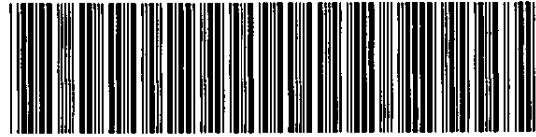



The Articles of Organization for this Limited Liability Company were filed on December 18, 2012, and assigned Florida document number L12000157370.


The Articles of Organization are amended as follows:
