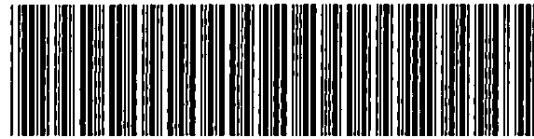


**ARTICLE IV — MANAGEMENT**




