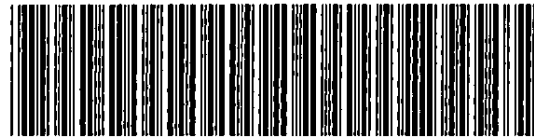


ARTICLE IV — MANAGEMENT




