

ARTICLES OF ORGANIZATION OF

FELDMAN FAMILY ENTERPRISES, LLC

- 1. Name. The name of this limited liability company is Feldman Family Enterprises, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. <u>Duration.</u> The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
