ARTICLES OF ORGANIZATION

OF

The undersigned, John D. Lefler, a natural person competent to contract and a member of JDL1 Services, LLC, hereby presents these Articles of Organization as the Articles of Organization of JDL1 Services, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is JDL1 Services, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

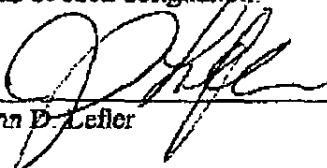
