**ARTICLES OF ORGANIZATION
OF
APK MANAGEMENT LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is APK Management LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be c/o Axel Preuss-Kühne, 2020 North Bayshore Drive, Apt. 2702, Miami, Florida, 33137.

ARTICLE III. REGISTERED AGENT AND OFFICE


ARTICLE IV. DURATION
