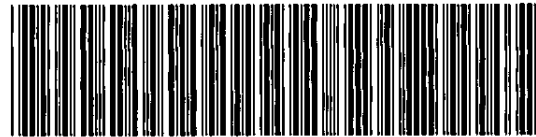

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **KPWS MANAGEMENT COMPANY, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on December 19, 2012, effective January 1, 2013, and assigned document number L12000158767.

1. Article 1 of the Articles of Organization is amended to read:

ARTICLE 1
Name

*The name of the Limited Liability Company is **KPWF Management Company, LLC**.*

2. Pursuant to Section 608.4231, F.S., and in accordance with the Operating Agreement of the Company, the sole Member authorized and consented in writing on January 3, 2013, to this Amendment to Articles of Organization. The vote was sufficient for approval.
