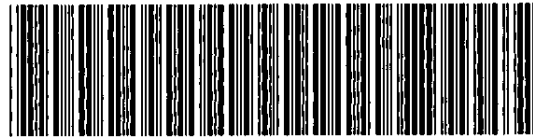




CERTIFICATE DESIGNATING REGISTERED AGENT
