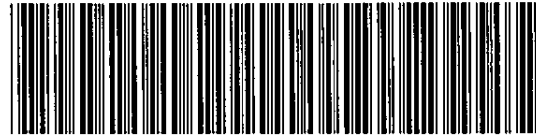

**THIS AMENDMENT TO THE ARTICLES OF ORGANIZATION OF ORANGE AND BLUE Management, LLC (the "Amendment")** is made and entered into effective on the date of filing with the Secretary of State of Florida by and between **the current member of ORANGE AND BLUE Management, LLC** a Florida limited liability company with an address of 800 Highland Ave., Suite 200, Orlando, Florida 32803 ("**Company**"), and the Company.

**W I T N E S S E T H:**

**WHEREAS**, the ARTICLES OF ORGANIZATION for this limited liability company were filed on December 19, 2012 and assigned Florida document number L12000159045;

**WHEREAS**, there has been a question as to the current managers of the Company based upon scrivener's errors and other documents of record; and

**WHEREAS**, the member wishes to clarify the names of the current managers of the Company by this Amendment.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and agreements set forth in this Amendment and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. **AMENDMENTS**. The Articles of Organization are hereby amended as follows:

Article IV. shall be replaced in its entirety and the following shall be inserted:

"ARTICLE IV-Management

The limited liability company is to be managed by one or more managers. The names and addresses of the Managers of the Company are:

Any Manager, acting alone, shall have the power to perform such acts, and transact such business as may be necessary for the business of the Company. Without limiting the foregoing,

and in addition to the powers conferred on the Managers by the Articles of Organization and any applicable Statute, each Manager, acting alone, shall specifically have the right or power to do any or all of the following acts:

(a) sell, assign, pledge, mortgage or otherwise encumber any of the property, real or personal, of the Company;

(b) borrow money in the name of the Company or utilize collateral owned by the Company as security for loans to the Company;

(c) assign, transfer, pledge, compromise or release any of the claims of or debts due the Company, or arbitrate or consent to the arbitration of any of the disputes or controversies between the Company and third parties;


(d) make, execute or deliver any guarantee, indemnity bond, surety bond, or contract to sell all or substantially all of the property of the Company;

(e) lease or mortgage any real estate of the Company or any interest therein or enter into any contract for any such purpose; or

(f) purchase, take, receive, lease or otherwise acquire real and personal property for the Company, and improve, use and manage any such real or personal property.

Except as hereinabove amended, the Articles of Organization as amended shall remain unchanged and shall continue in full force and effect.
