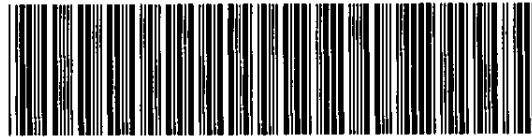

ARTICLE I - Name


ARTICLE V - Admission of Additional Members
