



The undersigned, as the Manager and Authorized Representative of the Members of GOMEZ TRUST, LLC, hereby files these Articles of Amendment to Articles of Organization pursuant to Section 605.0202 of the Florida Statutes and states as follows: —

1. The name of the Limited Liability Company is GOMEZ TRUST, LLC.
