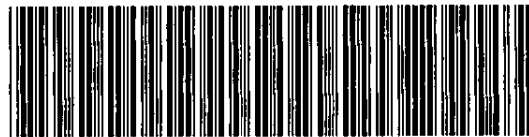

## ***ARTICLES OF ORGANIZATION OF ALLEN FARMS, LLC***


