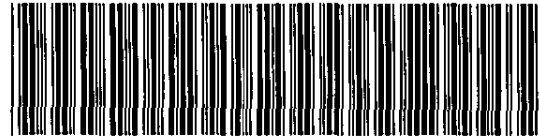

EFFECTIVE DATE 1/1/2013

ARTICLE 1 - NAME

The name of the limited liability company shall be **S-MESSADE LLC** ("Company").

ARTICLE 2 - ADDRESS

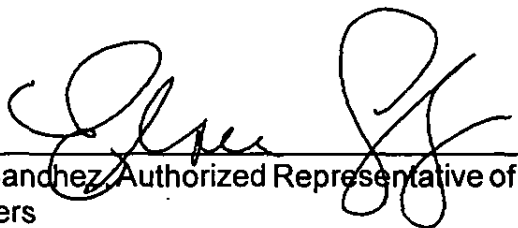
