2. The date of filing of the Articles of Organization of the Company was December 21, 2012 and assigned document number L12000159462.

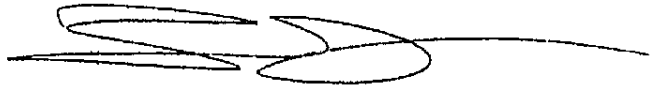
