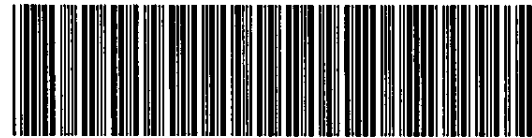

ARTICLE I - NAME

The name of the professional limited liability company shall be Dennis W. Ward, P.L. (the "Company").
