ARTICLES OF ORGANIZATION  
OF  
MYAKKA STOCK, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

ARTICLE I - NAME

The name of the Company is MYAKKA STOCK, LLC.

ARTICLE II - DURATION

The duration of the Company is perpetual.

ARTICLE III - ADDRESS AND PLACE OF BUSINESS

The street address and mailing address of the principal place of the principal office of the Company in Florida is 5700 Wauchula Road, Myakka City, Florida 34251.

ARTICLE IV - PURPOSE

ARTICLE VIII - INDEMNIFICATION


The Company shall indemnify each managing Member, manager, and officer to the fullest extent permitted by the Florida Limited Liability Company Act.


